### MILK

Memo: To all parents

JEC's optional lunch program this school year will be run by Elliot Rosenfeld (of Elizabeth's Jerusalem Pizza). Information about this program is available on thejec.org. Please note that school lunch includes a drink. Students who do not participate in the school lunch program must bring non-meat lunches from home.

As in the past, individual 8 oz. containers of either 2% or skim milk will be available for those who order in advance for the year. If you would like your child to receive milk, please complete this entire form and return it with payment.

Yeshiva students: The cost for milk each school day (not receiving school lunch) is \$70 or dairy days only (receiving school lunch) is \$42.

RTMA students eat lunch in school 4 days a week (Mon-Thu). The cost of milk for RTMA students who do not participate in the school lunch program is \$55 or \$28 for those who do participate in the school lunch program.
